2. The envelope carrying the bid must be super-scribed in capital letter with **"OFFER FOR AUCTION SALE OF VEHICLE"**.
3. The intending bidders are advised to inspect the above vehicle parked in the office campus of the Directorate of Public Prosecutions, Bhubaneswar in between 11.00AM to 4.00PM, on any working day. Each tender must accompany with an earnest money deposit of Rs 2,000/- (Rupees Two Thousand) only for the vehicle, in shape of Bank Draft made in any Nationalized Bank in favour of the Special Officer, Directorate of Public Prosecutions, Odisha, Bhubaneswar, which shall be refunded to the bidders, whose tenders are not accepted. The price offered shall not be less than the minimum (offset) price mentioned above in the case. The bidder should mention in the tender regarding the Vehicle No/Model/Make for which he would participate.
4. The Tender should reach before the undersigned by Registered Post/Speed Post or by hand on or before 05.07.2022 by 3.00 PM at the latest and tenders received shall be opened by the Auction Sale Committee in the Office Chamber of Special Officer, Directorate of Public Prosecutions, Odisha, Bhubaneswar on 08.07.2022 at 3.00 PM in the presence of the bidders or their authorized representatives. If the day is declared later as a Government Holiday, then the Tenders will be received and opened on the next working day as per the scheduled time. The undersigned will not be held responsible regarding late submission/receive of the Tender in any manner.
5. The highest Tenderer, whose tender is accepted, shall deposit 25% of the offered amount immediately then and there, as initial deposit. He shall deposit the balance amount within 7 (Seven) days of the deposit of the initial amount. In case, he fails to make deposit of the total amount as per the tender within the stipulated time, the deposit including the earnest money shall be forfeited. The EMD of successful bidder can be adjusted at the time of final payment of tender value.

GST as admissible shall be paid on the bidding cost by the successful bidder.

6. It will be the responsibility of the successful bidder to look after the vehicle at its own cost and the Directorate of Public Prosecution will not be responsible for any damage done by way of pilferage or otherwise and no claim on this account will be entertained.
7. The successful bidder shall take permission and remove the vehicle from the O/o Directorate of Public Prosecutions, Odisha, Bhubaneswar within 7 (Seven) days of deposit of the bid amount on its own cost. On failure to remove the vehicle within the aforesaid time span, ground rent @ 1% of the tendered amount shall be charged for each day or part of the day till removal of the vehicle from the aforesaid place. If the ground rent so charged, exceed the sale price deposit, the Tenderer shall cease to have any right on the vehicle and the amount deposited by him shall be adjusted towards the ground rent. Tools and implements of spare parts shall not be delivered with the vehicle.
8. The Authority reserves every right to reject any or all tenders without assigning any reasons thereof.
